In his 3 terms in the U.S. House of Representatives, David Trone has been an ally and advocate for labor unions and the workers they represent. David is proud to be the only candidate for the United States Senate with a 100% pro-labor voting record in Congress, and in the Senate, he'll continue to lead the fight for workers' rights.

From fighting to elect pro-labor and pro-worker candidates up and down the ballot to picking up the phone to fight for collective bargaining agreements with some of the nation's largest employers, David Trone has always stood tall for organized labor, and he always will.

Raising Wages and Economic Justice

David Trone understands the power of great wages, and believes it's unacceptable that there are tipped workers in Maryland making less than \$4 an hour. That's why he's a co-sponsor of the Raise the Wage Act of 2023, which would raise the minimum wage for all workers and ban the tipped wage for workers across the nation. In the Senate, David Trone will lead the fight to pass a minimum wage increase and ban the tipped wage while also working closely with allies in labor to invest in and expand union apprenticeship programs that give workers access to higher paying jobs with benefits that can sustain their families.

Protecting Workers and Fighting for Their Families

From making sure nurses on the front lines have safe staffing levels to working with Unite Here to guarantee their workers had COVID protections, David Trone stands with workers every time. No exceptions, no excuses. David Trone knows that workers across the country risk their lives every time they punch a timeclock, and has led the fight in Washington to give workers the resources they need to thrive, from worker training to access to mental health



services; and he led the fight in Congress to guarantee death benefits for emergency responders who lost their lives as a result of suicide related to their service. In the Senate, he'll sponsor legislation that guarantees paid family leave and gives every worker and their family stronger tools to succeed.

Collective Bargaining Agreements

David Trone understands the power that collective bargaining agreements give workers to raise wages, build safer workplaces and give American workers benefits that sustain their families.

When Maryland workers are negotiating for stronger wages and better benefits, David doesn't sit by, he takes action. David Trone isn't afraid to speak out for Maryland workers, and he's rolled up his sleeves to push CEOs and



management to negotiate in good faith and invest in their workforces and companies. In the Senate, David will fight to pass the PRO Act and lead the charge for legislation that guarantees and expands workers' rights.

Project Labor Agreements and Union Labor

Collective bargaining is just the first tool in ensuring strong wages and safe working conditions. David Trone understands how crucial Project Labor Agreements are to protect American workers, raise wages, and ensure vital public works projects are completed on time. David Trone is the only candidate for United States Senate with a proven track record of fighting for project labor agreements – no excuses, no exceptions.

- Pushed for the Maryland Stadium Authority to use union labor in the construction of the new baseball stadium in Hagerstown
- Fought for Project Labor Agreements in every state and federally funded project
- Worked with Carpenters to advocate solar farms to use union labor in their construction in Western Maryland
- Worked with Building Trades Council to encourage CEOs of data centers to engage in Project Labor Agreements for all of their building contracts for data centers built in Maryland
- Sponsor of this year's FIRE STATION Act, David supported having Davis-Bacon standards in grants for new fire stations

David Trone has always been a staunch supporter of public sector unions and the workers they represent. From successfully pushing for binding arbitration for firefighters to working with AFSCME to prevent privatization of a state run medical facility in Hagerstown, to addressing staffing shortages within the Department of Corrections, David Trone has always



had the backs of public sector workers. David doesn't hesitate to roll up his sleeves when he can help Maryland workers - that's why he picked up the phone to fight for one fair contract for the entire University of Maryland system, a huge win for local unions across the state. In the Senate, David Trone will introduce legislation that will guarantee wage protections for furloughed contract workers and ensure that no worker is left out.
